What do we need?

- 1. Tell us about the change in your household by completing the tables below.
- 2. Provide copies of income evidence for all people living at your home.

These can include:

- A Centrelink or Department of Veteran's Affairs Income and Assets Statement.
- An Employers Declaration or 4 weeks of payslips for each person receiving wages, a salary or casual income.
- A Tax Assessment Notice for the previous financial year for each self-employed person, including a Centrelink PAYG statement if also in receipt of a Centrelink income. Profit and loss statements are not accepted.
- Evidence of any other income received (for example, last quarterly bank statements, statements from financial institutions showing the total amounts of income earned from shares, bonds or managed investments).
- 3. All legal tenants in your household need to sign the declaration on the second page.
- 4. Post or deliver the form and household income information back to your local Housing Service Centre or email the information to HHSSDCPT@housing.gld.gov.au within 28 days of the change.
